Relating to property located at 505 E. Ash St., Columbia, Boone County, Missouri, and further described as follows:

The parties agree that the Grantor's above-described Deeds of Trust recorded in Book 787, Page 241 and Book 3573, Page 43, of the Boone County, Missouri Records remain in second position to the Providence Bank only and any other deed of trust required to be subordinated to the Providence Bank shall be behind and junior to the City's deed of trust.
