

**FIRST AMENDMENT to the
SOCIAL SERVICES PROVIDER AGREEMENT**

This First Amendment to the Social Services Provider Agreement is made as of the date of the last signatory noted below, between the **CITY OF COLUMBIA** (“CITY”), and **Wilkes Boulevard United Methodist Church**, (“Provider”).

RECITALS

- A. WHEREAS, on December 29, 2016, CITY and Provider entered into an Agreement (“Social Services Provider Agreement”) for homeless drop-in center services; and
- B. WHEREAS, the Parties hereto desire to formally amend the Social Services Provider Agreement with this First Amendment (hereinafter “First Amendment to the Agreement”) and desire to be bound by the terms contained in the Social Services Provider Agreement and those contained in this First Amendment to the Agreement.

AMENDMENT

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the Social Services Provider Agreement, as follows:

- 1. The last sentence of Section 1 of the Social Services Provider Agreement shall be replaced with the following:
“The total allowable compensation for the Program Services under this agreement shall not exceed thirty-five thousand dollars (\$35,000.00) per year for the first two years of the Agreement. The total allowable compensation for the Program Services under this agreement shall not exceed forty-seven thousand, six hundred and thirty-eight dollars (\$47,638.00) for the final year of the agreement.”
- 2. For the final year of the agreement, Exhibit A shall be replaced with the attached Exhibit A1.
- 3. The following subsection d will be added to Section 4 of the Social Services Provider Agreement:

“d. Payments related to the services provided according to the First Amendment to the Social Services Provider Agreement shall be as set forth herein.
 - i. Provider hereby acknowledges that City paid Provider twelve thousand and seventy dollars (\$12,070.00) in January of 2019.
 - ii. Upon receipt and approval of the interim report, City will pay Provider seventeen thousand seven hundred and eighty-four dollars (\$17,784.00).

iii. Upon receipt and approval of the final report, City will pay Provider seventeen thousand seven hundred and eighty-four dollars (\$17,784.00).”

4. All other terms of the Social Services Provider Agreement shall remain unchanged and in full force and effect.
