Executive Summary

A draft ordinance has been prepared for City Council consideration that would prohibit licensed professionals from practicing conversion therapy on juveniles.

Discussion

Following a request by The Center Project, the Human Rights Commission (HRC) began researching conversion therapy. After a brief consultation with the Board of Health, HRC unanimously voted to recommend that the City Council pass an ordinance that would make it unlawful for licensed professionals to administer conversion therapy upon juveniles. The City Council discussed the HRC report at the Council's meeting on February 18, 2019, and unanimously approved a motion, made by Mayor Treece and seconded by Council member Trapp, directing staff to prepare an ordinance for the City Council's consideration.

While conversion therapy is currently not prohibited by state statute, the major professional associations of mental health practitioners and researchers, such as the American Psychological Association, American Psychiatric Association, the American School Counselor Association, the American Medical Association Council on Scientific Affairs, the National Association of Social Workers, the American Counseling Association Governing Council, the American Psychoanalytic Association, the American Academy of Child and Adolescent Psychiatry, have opposed the use of conversion therapy. Some cities have adopted ordinances prohibiting the practice.

Staff has prepared a draft bill to amend Chapter 16 of the City Code to prohibit licensed medical or mental health professionals from providing conversion or reparative therapy on a minor. A violation of this prohibition would be a Class A misdemeanor punishable by a fine not to exceed \$2,000.00 and/or by confinement for a term not to exceed one (1) year.

Should the City Council wish to amend Chapter 16 of the City Code to prohibit licensed professionals from practicing conversion therapy on juveniles, staff recommends that the Council direct staff to place the attached bill on Council's June 3, 2019 meeting agenda for introduction and first reading.
