Executive Summary

Staff requests that Council authorize the City Manager to execute a contract with Graham Construction, Inc., and appropriate funds in the amount of \$300,000 for repairs to the Fifth Street and Walnut Street parking garage.

Discussion

In late 2018, Walker Parking Consultants performed a structural evaluation of the Fifth Street and Walnut Street parking garage and determined that there were issues related to the precast spandrel panels on the east and west faces of the garage. The original contractor, Graham Construction, Inc. was notified and agreed to compensate the City \$300,000 for the estimated costs related to the repairs. Staff is appropriating these funds to the Fifth and Walnut Repairs project account.

The repairs will be performed by Tarlton Corporation and are scheduled for this spring/ summer timeframe. Although there will be some areas of the parking garage that will be non-accessible during the repairs, the garage will remain open to the public.
