Re: Appropriating Funds to the Providence Road Improvement Project

Executive Summary

Staff is appropriating funds in the amount of \$70,000 as a result of a condemnation settlement between the City of Columbia and Missouri Alpha of Phi Kappa Psi Fraternal Corporation relating to the completed Providence Road improvement project.

Discussion

On December 21, 2015 Council passed Council Bill 354-15 authorizing the construction of street improvements on Providence Road from Stadium Boulevard to Stewart Road. Due to the need to acquire certain street easements and temporary construction easements for construction of the project, it was necessary to condemn a tract of land owned by Missouri Alpha of Phi Kappa Psi Fraternal Corporation. A commissioner's condemnation award of \$220,000 was issued in December of 2017 which had been budgeted and paid for from the Providence Road improvement project. This case was finally settled on May 15, 2019 with an additional award of \$70,000. Staff is appropriating these funds from Annual Streets budget to the Providence Road improvement project.

Fiscal Impact

Short-Term Impact: The commissioner's condemnation award in the amount of \$220,000 was issued in December of 2017, and paid from the Providence Road improvement project. An additional \$70,000 has been awarded to settle the case and these funds are being appropriated from the Annual Streets budget to the Providence Road improvement project. Long-Term Impact: None
