budget as Future Ballot

## **Executive Summary**

The water ballot issue, approved by voters in August 2018, authorized a total of \$42,845,000 of funding for water capital projects for the period FY 2019 through FY 2023. Water and Light is requesting that \$13,250,000 be appropriated from the proceeds of the first water bond sale to projects identified in the FY 2019 budget as being Future Ballot funded.

#### Discussion

Water and Light is requesting that \$13,250,000 be appropriated from its Restricted Revenue Bond account to six Water Capital Projects that were identified with a FY 2019 funding source of Future Ballot. The following table lists the specific projects and the amount of funding allocated to the project for FY 2019.

Project	Description	Funding
W0125	Annual Main Relocation for Streets & Highways	\$300,000
W0130	Annual Water Main Replacements	\$750,000
W0286	New Elevated Storage	\$3,000,000
W0280	New Southeast Pump Station	\$3,200,000
W0236	Water Treatment Plant Upgrade – Phase 1	\$3,000,000
W0145	West Ash Upgrades	\$3,000,000

The appropriation of the funds are needed to begin construction of the projects identified for FY 2019 funding in the August 2018 ballot issue.
