Re: Temporary Waiver from the Requirements of Section 16-185 of the City Code to Allow

Possession and Consumption of Alcoholic Beverages

#### **Executive Summary**

Staff has prepared for Council consideration a resolution granting a waiver from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages for the annual Rally in the Alley event.

#### Discussion

Global First Responder Board President Adam Beckett has requested a waiver from the requirements of section 16-185 of the City Code, from 5:30 p.m. until 9:30 p.m. on June 20, 2019. The estimated attendance for the event is 150 people.

For the past three years, the City Event Committee has approved the closure of the alley between Walnut and the Landmark Bank Parking lot and the alley between 8<sup>th</sup> and 9<sup>th</sup> Streets for this event. The setup for this year's event appears to be the same in years past. Conditions of approval have included use of barricades that are compliant with the Manual on Uniform Traffic Control Devices (MUTCD) to block the alley and procurement of required liquor licensing. The city's Special Event Permit application has been completed and approved.
