Re: Amending Chapter 22 of the City Code to modify the private source inflow and

infiltration reduction program

#### **Executive Summary**

Staff has prepared for Council consideration an ordinance amending Chapter 22 of the City Code as it relates to the Cost Reimbursement Program for Private Source Inflow and Infiltration Reduction. This amendment would expand the program to allow for reimbursement for the removal of area drains with contributing areas larger than 75 square feet and for minor site grading or concrete work to direct storm water runoff away from sanitary sewer inflow sources.

#### Discussion

On May 20, 2019, staff presented to council a report on proposals to expand the Cost Reimbursement Program for Private Source Inflow and Infiltration Reduction and the Cost Reimbursement Program for the Installation of Pressure Sewers/Backflow Devices or Removal of Plumbing Fixtures. In the report, staff recommended the Private Source Inflow and Infiltration Reduction Program (hereinafter referred to as the "Program") be expanded to include two potentially significant sources of inflow. These items are as follows:

- Disconnection of driveway/stairwell/patio area drains that have a contributing area larger than 75 square feet, 100% reimbursement of cost up to \$1,500.
- Minor site grading or concrete work to direct storm water runoff away from sanitary sewer inflow source, 100% reimbursement of cost up to \$1,000.

As with the other items identified for reimbursement under the Program, the director will consider each of the items on a case-by-case basis to determine the likelihood of inflow and infiltration from these sources and its impact to the sewer system. This will help ensure that the funding allotted to these programs is utilized in an efficient manner and are focused on work that eliminates a direct connection/source of inflow or reduces amount of inflow to the sanitary sewer system.

### Fiscal Impact

Short-Term Impact: The fiscal year 2019 budget includes \$100,000 for reimbursement to property owners for Inflow and Infiltration reduction.

Long-Term Impact: \$100,000 will be included in the operating budget in future years for this reimbursement program. Increased participation in the program may warrant increasing the funding in the future with an ultimate decrease as sources of inflow and Infiltration are removed.
