Executive Summary

Authorize the City Manager to execute an Electric Distribution Line Relocation agreement with Boone Electric Cooperative for the Nifong Boulevard Intersections Improvement project. The improvements include relocating the existing electric distribution line at the Nifong Boulevard/Vawter School Road and Old Mill Creek/Country Woods Road intersection to allow for the construction of a roundabout.

Discussion

The Nifong Boulevard Intersections Improvement project includes constructing two (2) 120foot diameter single-lane roundabouts at the intersections of Nifong Boulevard and Sinclair Road, and Nifong Boulevard/Vawter School Road and Old Mill Creek Road/Country Woods Road. The roundabouts are designed so they can be widened to 150-foot diameter partial dual-lane roundabouts in the future when Nifong Boulevard is widened to four lanes. The design includes splitter islands, sidewalks, and street lighting.

As part of the development of the project's final plans, it was determined that Boone Electric Cooperative will need to relocate an existing electric distribution facility that is currently located in a private easement at the Nifong Boulevard/Vawter School Road and Old Mill Creek Road/Country Woods Road intersection. The cost for the relocation is \$92,050. Construction is planned to begin on this intersection during the winter or spring of 2020.

Fiscal Impact

Short-Term Impact: The cost for the electric distribution line relocation is \$92,050 and is included in the total estimated cost of \$2,573,000 for the entire intersections improvement project. This cost includes design, right of way, utilities, and construction, and will be paid from the 0.25% Capital Improvement Sales Tax.

Long-Term Impact: Routine maintenance for each roundabout is estimated at \$2,000/year.
