Re: Authorize a First Supplemental Agreement with Missouri Highways & Transportation Commission as it relates to the Reconstruction of Runway 13-31 and Taxiway C Projects at

the Columbia Regional Airport

Executive Summary

Authorize the City Manager to execute a First Supplemental Agreement to the Airport Aid Agreement with Missouri Highways & Transportation Commission (MHTC) to extend the project time period for one additional year, as it relates to the reconstruction of Runway 13-31 and Taxiway C projects at the Columbia Regional Airport.

Discussion

In an effort to assist with financial aid related to the construction of a new terminal at the Columbia Regional Airport, MHTC agreed to reimburse the City \$775,414.00, which is equal to fifty percent (50%) of the City's local match required from the Federal Aviation Administration (FAA) for the reconstruction of the Runway 13-31 and Taxiway C projects. On May 21, 2018, Council Bill 112-18 was passed authorizing an airport aid agreement with MHTC, and appropriating the grant funds. The airport aid agreement expired June 30, 2019; however, due to a balance of \$51,055 remaining on the grant, MHTC has agreed to amend the agreement to extend the project time period through June 30, 2020.

Fiscal Impact

Short-Term Impact: A total of \$775,414 was appropriated from the state revenue account per Ordinance 023550. To date, MHTC has reimbursed the City \$724,359, leaving a balance of \$51,055 yet to be reimbursed.
