Re: Authorizing Amendment No. 1 to the professional services agreement with Intuition &

Logic Engineering, Inc., for the floodplain analysis of Mill Creek east of Bethel Street

Executive Summary

Staff has prepared for Council consideration a resolution authorizing the City Manager to execute Amendment No. 1 to the professional services agreement with Intuition & Logic Engineering, Inc. to provide additional engineering services for the floodplain analysis of Mill Creek east of Bethel Street. The additional services are not to exceed \$5,345.

Discussion

The scope of services for this engineering agreement consists of the consultant revising the flood plain mapping (for submission to the Federal Emergency Management Agency) of Mill Creek upstream of Bethel Street to change it from an Un-numbered A Zone into a Numbered A Zone with revised floodplain delineation, flood elevations, and a delineated Floodway. See attached diagram.

Based on preliminary engineering work, it is recognized that additional engineering services are required to develop a more detailed representative flood inundation mapping within the extended model area, particularly near Valencia Drive. More detailed information will provide additional benefit to the property owners with regard to flood elevations. Also included in the additional scope of services is time for the consultant to attend a public information meeting to be available for questions related to the proposed map revisions and assist in developing responses to public comments.

Additional engineering costs are anticipated to be \$5,345. for a total contract not to exceed amount of \$36,125.

Fiscal Impact

Short-Term Impact: The new total not to exceed agreement amount is \$36,125; \$5,345 is the additional engineering costs associated with this amendment.
