Executive Summary

This ordinance authorizes the issuance of Water and Electric Refunding Revenue Bonds, Series 2019B.

Discussion

The attached ordinance authorizes the issuance of Water and Electric System Refunding Revenue Bonds, Series 2019B, which will be used to refund the outstanding principal amount of the Water and Electric System Revenue Bonds Series 2009A of \$14,490,000 and the outstanding principal amount of the Water and Electric System Revenue Bonds Series 2011A of \$64,215,000, as well as issue costs. This refinancing is estimated to save the City approximately \$9.6 million net present value over the next twenty-two years.

The "Notice of Bond Sale", a copy of which marked "Exhibit A," and "The Preliminary Official Statement", a copy of which marked "Exhibit B," are attached to the Resolution.

Fiscal Impact

Short-Term Impact: It is estimated that this refunding issue will save approximately \$1.3 million over the next two years.

Long-Term Impact: It is estimated that this refunding issue will save approximately \$9.6 million net present value through year 2042.
