## AN ORDINANCE

amending Ordinance No. 023938 to correct the legal description for the District M-C (Mixed-Use Corridor) tract within Auburn Hills Plat 17 located on the northeast corner of the intersection of Brown School Road and Highway 763; and fixing the time when this ordinance shall become effective.

WHEREAS, Ordinance No. 023938, passed on August 5, 2019, authorized the rezoning of property located on the northeast corner of the intersection of Brown School Road and Highway 763 from District PD (Planned Development) to District M-C (Mixed-Use Corridor), District M-N (Mixed-Use Neighborhood) and District M-OF (Mixed-Use Office); and

WHEREAS, an error was discovered in the legal description for the portion of the acreage rezoned to District M-C (Mixed-Use Corridor) that needs to be corrected.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Section 1. of Ordinance No. 023938 is amended by replacing the legal description as follows:

SECTION 1. The "Official Zoning Map of the City of Columbia, Missouri" established and adopted by Section 29-1.4 of the Code of Ordinances of the City of Columbia, Missouri, is amended so that the following property will be rezoned and become a part of District M-C (Mixed-Use Corridor) and taken away from District PD (Planned Development):

SECTION 2. This ordinance shall be in full force and effect from and after its passage.
