Executive Summary

Staff is requesting Council authorize the City Manager to execute a Consultant Agreement with Burns & McDonnell, Inc. to assist the City of Columbia in the design of Taxilane C2 and apron expansion for the new Hangar 730 which replaces Hangar 350 at Columbia Regional Airport. The project cost is \$165,186.00.

Discussion

The Consultant Agreement with Burns & McDonnell Engineering, Inc. will provide design services related to the design of Taxilane C2 and apron expansion for the new Hangar 730 which replaces Hangar 350. The project cost for design services is \$165,186.00 and is eligible for 90% reimbursement from the Missouri Department of Transportation (MoDOT). The remaining 10% will be funded with Transportation Sales Tax (TST).

Fiscal Impact

Short-Term Impact: The Consultant Agreement is \$165,186.00. Missouri Department of Transportation (MoDOT) will reimburse the City 90% or \$148,667.40. The City will fund 10% from Transportation Sales Tax or \$16,518.60.
