Re: Report: Vision Commission's Recommended Goals for Strategic Planning

Executive Summary

The Vision Commission and City staff members conducted a focus group process last year designed to gather community input for our next strategic plan. The attached Commission report summarizes themes important to those who participated and suggests three actionable goals (strongly related to leadership) for Council consideration. The Commission's work is based on the Strategic Plan Focus Group Report published in May 2019.

Discussion

City Ordinance Sec. 2-303(c) establishes this mandate for the Vision Commission.

(c) Public engagement. The commission, through various means, will collect public input on the strategic and relevant plan initiatives and departmental goals. The commission, in preparation for its annual report submitted to the city council, will hold at least four public hearings for public comment on the current state of city initiatives and collected public feedback.

As part of its contract to facilitate development of the City's next strategic plan, New Chapter Coaching, LLC was retained to help the Commission design and conduct a public engagement process, adapted from the successful Columbia/Boone County community health planning model. Eight groups (with an average 17 participants) were asked to answer several broad questions about community priorities, with City staff compiling and analyzing input for Vision Commission review.

Conversations with low-income persons, older persons, youth, persons with disabilities, businesses and the public at-large were held in December 2018 and January 2019. Commission members participated as facilitators, meeting hosts and in other capacities as their time allowed. The focus group document is attached to this report.
