A RESOLUTION

setting a public hearing; declaring the necessity for the proposed construction of a sidewalk on the north side of Leslie Lane between Garth Avenue and Newton Drive; stating the nature of and the estimate of the cost of the proposed improvement; providing source of funds for payment for the proposed improvement; and providing for compliance with the prevailing wage law.

WHEREAS, an interested parties meeting for the proposed construction of a sidewalk on the north side of Leslie Lane between Garth Avenue and Newton Drive was held by the Public Works Department on September 19, 2019.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. A public hearing in respect to the proposed public improvements set forth herein will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on November 4, 2019. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.

SECTION 2. The City Council deems the proposed construction of a five-foot wide concrete sidewalk with three-foot wide greenspace along the north side of Leslie Lane between Garth Avenue and Newton Drive, installation of ADA compliant curb ramps at the Newton Drive entrance, and replacement of a 48-inch cross road culvert and inlets, necessary to the welfare and improvement of the City but desires to hear from the public prior to taking further action to authorize construction of the project.

SECTION 3. The nature and scope of the proposed improvement project shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements. Following the public hearing the City Council shall determine whether it is in the public interest to make the proposed public improvements or any part thereof.

SECTION 4. The estimated cost of this proposed improvement is \$215,000.00.

SECTION 5. Payment for the proposed improvement project shall be made from funds received from the Missouri Highways and Transportation Commission, capital improvement sales tax funds and such other funds as may be lawfully appropriated. According to the terms of a Transportation Alternatives Funds and STP-Urban Funds program agreement, the Missouri Highways and Transportation Commission will reimburse the City 80% of the estimated construction cost in an amount not to exceed \$172,000.00 and the City is responsible for the balance of the project costs.

SECTION 6. Any work done in connection with the construction of the proposed improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri. The City shall also cause to be inserted into the contract a stipulation that all laborers and mechanics employed by the contractor or subcontractors in the performance of work under the contract shall be paid wages at rates not less than those prevailing on similar construction in the locality as determined by the Secretary of Labor in accordance with the Davis-Bacon Act.
