Item 3: Review and Approval of Agenda

Yonke made a motion to forward the draft proposed FY 2020 UPWP with the amended language regarding the West Area Plan work, to the CATSO Coordinating Committee for a public hearing at their August meeting. The motion was seconded by Christian. The motion passed unanimously.

Item 7: DRAFT CATSO 2050 Long-Range Transportation Plan

Communication between staff and MoDOT and OneDOT is ongoing and more revisions are anticipated.

It was suggested that language be added to the draft LRTP to mention support for the Rocheport I-70 bridge replacement project, and its impact on the CATSO MPA, even though it is located outside the MPA boundary. Also suggested was the addition of brief discussion about autonomous vehicles and their potential impact on the transportation system. Staff agreed to make these edits as requested.
