Re: Sponsorship Agreement with MU Health Care for the Sports Fieldhouse

Executive Summary

This agreement replaces the agreement on B307-19 that was approved at the October 21, 2019 Council Meeting due to a section inadvertently left out of the agreement.

The Parks and Recreation Department is requesting legislation to authorize a sponsorship agreement with The Curators of the University of Missouri on behalf of University of Missouri Health Care (MUHC) granting MUHC the right to have its logo and approved signage in Court 3 of the Columbia Sports Fieldhouse located in A. Perry Philips Park, and Court 3 will be named the "MU Health Care Court." MUHC will pay \$20,000 per year for five years, for a total of \$100,000 for the rights and benefits provided as a sponsor of Court 3.

Discussion

The Columbia Sports Fieldhouse development project was approved by City Council on March 19, 2018. Raising money through sponsorships was included in the funding plan for the project. MU Health Care has agreed to sponsor Court 3 and will pay \$20,000 per year for five years, for a total of \$100,000. MU Health Care will have its logo and approved signage on Court 3, and Court 3 will be named the "MU Health Care Court" and referenced such in all documents, promotional material, signage throughout the facility, verbal mentions, etc. The agreement will be in effect for five years.

This agreement replaces the agreement on B307-19 that was approved at the October 21, 2019 Council Meeting due to a section inadvertently left out of the agreement.

Fiscal Impact
