Re: Public Hearing for the new terminal at the Columbia Regional Airport

Executive Summary

A public hearing is being held on November 18, 2019, for construction of the new terminal at the Columbia Regional Airport to allow a resolution of necessity. Staff anticipates that the construction will commence in the summer of 2020 and be completed in spring of 2022. An interested parties meeting was held on March 22, 2016. At the conclusion of this meeting there were no objections to this project being completed.

Discussion

The current Columbia Regional Airport terminal was opened for commercial traffic in 1969 and has served the mid-Missouri region for over 50 years. Increased security regulations, passenger growth, aging infrastructure, and limited ADA accessibility have made the construction of a new terminal a priority for the City of Columbia. The current facility has approximately 16,000 square feet, two former Columbia Public School (CPS) trailers for secure gate areas, one former CPS trailer for baggage claim, and only one bathroom in the secure area to accommodate up to 177 people.

An interested parties meeting was held on March 22, 2016, for the Terminal Area Master Plan (TAMP). There were many comments but no objections to the future construction. The City Council reviewed information from the TAMP during a City Council Work Session on February 15, 2016. This study included six potential locations for the new terminal. This study also concluded that the rate of growth exceeded the capacity of our current facility. To meet the demand for this growth it was apparent that the City of Columbia must move forward quickly with the construction of the new commercial terminal.

On December 18, 2017, City Council passed a resolution providing their support for the location identified as Site 1X. This location is just south of the existing terminal and east of Airport Drive. This location was supported with three priorities in mind: Timing, Cost, and Sustainable Practices- all the while meeting safety and security regulations and allowing for expansion as future growth demands. After this resolution of support was passed, staff was required by the Federal Aviation Administration (FAA) to complete a Supplemental Terminal Area Masterplan (STAMP) due to this new location that had not been previously identified in the original TAMP. On June 24, 2019, the FAA accepted the STAMP and approved the revised Airport Layout Plan which identified the approved Site 1X for the new commercial terminal.

On July 1, 2019, City Council passed a resolution authorizing an agreement with Burns & McDonnell Engineering, Inc. to provide engineering and architectural services to represent

the City of Columbia as the Owner's Representative for the development of a Basis of Design document that will be utilized for the procurement of a Design-Builder for the new Columbia Regional Airport Terminal.

On July 15, 2019, a Pre-Council Work Session was held where staff presented an update of the airport terminal project and discussed the pros and cons of the three options considered for design and construction: Design/Bid/Build, Construction Manager at Risk, and Design/Build. Council members expressed support for the Design/Build method which expedites the construction, reduces costs, and thus reduces risks to the City of Columbia while meeting the demands of the increasing passengers utilizing COU. On August 15, 2019, the City received approval from the FAA to utilize the Design/Build method.

Based on the projected passenger growth, the new terminal will be approximately 60,000 square feet. The construction will be a phased approach with the first phase cost of approximately \$20,000,000.00. Staff intends to include bid alternates for the construction project Phase 1, which is planned for calendar years 2020, 2021, and 2022. Subsequent phase(s) will be determined after the RFQ is awarded and any additional funding is determined.

Additionally, Airport staff has held monthly "All Things Airport" meetings with the community about this project since August 2018 and plans to continue outreach and meetings until the terminal is completed. This has allowed staff to provide updates to users and partners of the airport in the community. This has also allowed input of ideas that customers and partners would like to see incorporated into the terminal. To ensure collaboration with the surrounding communities, staff has also traveled to Callaway, Randolph, Cooper, and Cole counties to receive and provide feedback to the customers and partners that are also served.

Fiscal Impact

Short-Term Impact: The first phase of construction allowed in the design/build will be approximately \$20,000,000.00 and will be completed in 2022.

Long-Term Impact: Future phase(s) of the terminal will cost approximately \$15,000,000.00.
