Re: Set Public Hearing - Rice Road to Geyser Boulevard Street Name Change (Case #237-

2019)

Executive Summary

Approval of the resolution would set December 16, 2019 as the public hearing date for the requested street name change of Rice Road to Geyser Boulevard, as required by Section 24-15 of the Municipal Code.

Discussion

D & D Investments of Columbia, LLC (applicant) is seeking to rename Rice Road to Geyser Boulevard, beginning at Ballenger Lane and continuing east to its terminus at Lake of the Woods Road, an approximately one-mile long stretch of roadway.

Per Section 24-15 of the Municipal Code, the City Council must conduct a public hearing on the proposed street name change, unless all owners of property that abut the street have signed a petition supporting the renaming of the roadway. At this time, the City has not received petitions from all abutting property owners; therefore, a public hearing is required.

Currently, Rice Road begins at Lake of the Woods Road, and continues west until it transitions to Hanover Boulevard, a distance of approximately 1.6 miles. The requested name change proposes to change only that segment of Rice Road located east of Ballenger Lane – an approximate one-mile stretch of the roadway. The portion of the street west of Ballenger Lane would continue to be known as Rice Road, up to the point it transitions to Hanover Boulevard.

Pursuant to the provisions of Section 24-15 of the City Code, the Planning and Zoning Commission considered this request at their November 7, 2019 meeting. Following presentations by the staff and applicant as well as public comments, the Commission made a motion to approve the requested name change. The motion failed (2-6) to pass.

The full Planning Commission staff report inclusive of the application letter, Boone County Zoning Regulations 27.9.11 (excerpt) and meeting minute excerpts are being concurrently introduced (Case #237-2019) on the December 2, 2019 Council agenda as a separate action item.
