MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION UTILITY EASEMENT FOR FIBER OPTIC CABLE

Box 6015, Columbia, MO 65205-6015 (grantor), and the State of Missouri, acting by and through the Missouri Highways and Transportation Commission, 105 W. Capitol Avenue, P.O. Box 718, Jefferson City, MO 65102, (grantee).

WITNESSETH, that the said grantor, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, to it paid by the said grantee, the receipt of which is hereby acknowledged, does by these presents grant, bargain and sell, convey and confirm unto said grantee, its successors and assigns, the following described permanent easement and interests in real estate in the County of Boone, State of Missouri, to wit:

A permanent utility easement for the installation and maintenance of fiber optic cable located in the Southwest Quarter of Section 32, Township 49 North, Range 12 West lying within the Right of Way of the Columbia Terminal (formerly Wabash) Railroad, being more particularly described as follows:

Commencing at the North quarter corner of Section 5, Township 48 North, Range 12 West; thence coincident with the Township Line between Section 5, Township 48 North, Range 12 West and Section 32, Township 49 North, Range 12 West S 89 deg. 44 min. 15 sec. W a distance of 1170.81 feet to a point on the Easterly line of the Columbia Terminal Railroad said point being 50 feet offset from the centerline of said Railroad and also being the POINT OF BEGINNING of this description; thence departing said Easterly line continuing coincident with said Township line S 89 deg. 44 min. 15 sec. a distance of 34.43 feet to a point 25 feet offset from said railroad; thence departing said Township line N 43 deg. 11 min. 01 sec. E a distance of 1156.59 feet to a point 25 feet offset from said Railroad; thence S 46 deg. 48 min. 59 sec. E a distance of 25.00 feet to the Easterly line of said Railroad; thence coincident with said easterly line S 43 deg. 11 min. 01 sec. W a distance of 1132.91 feet to the point of beginning, containing 0.66 acres.

Also, a permanent utility easement for the installation and maintenance of fiber optic cable located in the West Half of Section 5 and the East Half of Section 6, Township 48 North, Range 12 West lying within the Right of Way of the Columbia Terminal (formerly Wabash) Railroad, being more particularly described as follows:

Commencing at the North guarter corner of Section 5, Township 48 North, Range 12 West; thence coincident with the Township Line between Section 5, Township 48 North, Range 12 West and Section 32, Township 49 North, Range 12 West S 89 deg. 44 min. 15 sec. W a distance of 1194.22 feet to a point on the Easterly line of the Columbia Terminal Railroad said point being 33 feet offset from the centerline of said Railroad and also being the POINT OF BEGINNING of this description; thence departing said Easterly line continuing coincident with said Township line; S 89 deg. 44 min. 15 sec. W a distance of 20.66 feet to a point 18 feet offset from said railroad; thence departing said Township line coincident with a line 18 feet easterly of and parallel to the centerline of said railroad the following three courses: S 43 deg. 11 min. 01 sec. W a distance of 688.88 feet; thence along a curve to the left, the radius being 5742.68 feet, the central angle being 05 deg. 52 min. 05 sec., the arc length being 588.16 feet, the chord being S 40 deg. 14 min. 58 sec. BEGINNING at the Northeast corner of Vandiver Crossing Plat 2, a subdivision recorded in Boone County Book 3835, Page 122 said Northeast corner being at the intersection of the Westerly line of the Columbia Terminal Railroad and the Southerly line of Vandiver Drive; thence coincident with said Westerly line, N 37 deg. 18 min. 56 sec. E a distance of 156.00 feet; thence departing said Westerly line S 52 deg. 41 min. 04 sec. E a distance of 51.00 feet; thence S 37 deg. 18 min. 56 sec. W a distance of 200.00 feet; thence N 52 deg. 41 min. 04 sec. W a distance of 51.00 feet; thence

coincident with the aforesaid Westerly line N 37 deg. 18 min. 56 sec. E a distance of 44.00 feet to the point of beginning, containing 10200.0 square feet.
