Executive Summary

This is the public hearing for the proposed construction of PCCE #25 Glenwood Avenue Sanitary Sewer improvement project. The project location is shown on the attached Location Map. The resolution estimate for this sewer project is \$300,000, and payment shall come from the Sewer Utility Private Common Collector Elimination (PCCE) Funds.

Discussion

In May 2019, Council directed staff to proceed with the preliminary design of a sanitary sewer improvement project to address a petition associated with the Glenwood Avenue private common collector sewers. Based upon site inspections and CCTV reports, eight properties in the area are connected to private common collector sewers and eligible for improvement to public gravity sewers. The remaining homes in the area have separate sewer laterals that are directly connected to public sewer and are not eligible to be part of the project.

As shown on the attached diagram, PCCE #25 Glenwood Avenue Sanitary Sewer Improvement Project will consist of installing approximately 440 feet of CIPP (Cured in Place Pipe) and constructing approximately 347 feet of new gravity sewer main and five sanitary sewer structures. The proposed project will also include new private service connections and replacement of service laterals only as necessary to reconnect the existing laterals to the new sewer main. The proposed sanitary sewer project will eliminate a private common collector sewer in the area that serves two properties along Glenwood Ave. The proposed project will also rehabilitate, extend, and take ownership of an existing privately maintained sanitary sewer main located in the right-of-way that serves six properties on Glenwood Ave.

Currently, it is required that the temporary construction easements and permanent sewer easements necessary for the construction of the project be donated by the property owners of the parcels currently being served by the PCC sewers. However, in addition to the donated easements, this project will require the acquisition of permanent sewer easements and temporary construction easements from two property owners representing three parcels that are currently served by public sewers, therefore not required to donate easements.

Sewer Utility staff held Interested Parties (IP) Meetings for the project on August 21, 2018 and September 4, 2019. Of the eleven properties affected, owners representing five of the properties attended the meetings. Owners from three other properties in the area attended

as well. The City met the other affected property owners at their homes. All property owners are in support of this project.

The resolution estimate for this project is \$300,000. In accordance with Section 22-253 of City Code, financing for this project will be through the Sewer Utility Private Common Collector Elimination funds.

Fiscal Impact

Short-Term Impact: The resolution estimate is \$300,000 and will be paid from the Sewer Utility Private Common Collector Elimination funds.

Long-Term Impact: It is anticipated that this project will have a minimal impact on the Sewer Utility's annual operating cost.
