Re: Amending Chapter 22 of the City Code to provide different requirements for calculating

monthly volume charges for residential sewer service.

Executive Summary

Staff has prepared for Council consideration an ordinance amending Chapter 22 of the City Code to provide new formulas for calculating the monthly sewer volume charge for customers in the residential classification. The proposed ordinance revisions will result in the ordinance requiring the monthly sewer volume charge to be calculated in a manner that corresponds to the capabilities of the current billing software, reducing the potential for billing errors. These changes are not anticipated to have a fiscal impact.

Discussion

Section 22-263 (b) of the City Code defines how the monthly volume charge for sewer customers is to be calculated. The City's billing software cannot accurately calculate the volume charges as described in the ordinance, in some instances. When volume charges cannot be accurately calculated by the billing system, large amounts of staff time is required to identify and correct errors and requires manually overriding the system so that accurate bills are generated. The proposed changes will result in the ordinance and the billing system using the same methods to calculate sewer volumes, reducing the potential for billing errors and reducing staff time to manually enter overrides. The changes are summarized below:

- The monthly sewer volume for residential customers is currently based on the average water use in the winter to avoid charging sewer fees for water used for irrigation purposes. The average is calculated by from water use data for November, December, January, February and March. The highest month and the lowest month are discarded and the three remaining months are averaged. The current billing software cannot calculate this accurately in many instances. This will be changed to average the water use data during the months of January, February and March. The system is capable of performing this calculation accurately. This average also corresponds to the average used for water purposes and should be less confusing for the customers.
- Currently, if the average calculated is less than 1 CCF, then the average is calculated based on a full year of water use, including water used for irrigation. The ordinance revisions will eliminate this calculation and instead use the actual average use even if less than 1 CCF. In addition, it establishes a minimum sewer volume of 0.33 ccf.
- Currently, the winter average transfers for any residential customer that moves to a
 different address. The current billing software cannot perform this calculation. This
 results in staff having to identify the incorrect system calculated bill and manually

calculate the volume charge and override the system. The ordinance revisions will eliminate the transfer of existing averages and residential customer that moves will have a monthly volume that is equal to the average used for all new residential customers.
