Re: Authorizing a Bid Call for the Reconstruction of Taxilane C2 and Apron Expansion at the

Columbia Regional Airport; and appropriate funds.

Executive Summary

Authorize a bid call through the Purchasing division for the reconstruction of Taxilane C2 and Apron Expansion at the Columbia Regional Airport; and appropriate funds. Staff anticipates that the project will be constructed in FY2020. An Interested Parties' meeting was held on March 18, 2018, and a Public Hearing was held on May 21, 2018.

Discussion

Staff is requesting that Council authorize a bid call through the Purchasing division for the reconstruction of Taxilane C2 and Apron Expansion. In addition to this, the project will extend the Taxilane and include a new Apron in front of the future Hanger 730 site. These improvements will include concrete which supports larger aircraft, longer life, and future development of this area.

Council authorized a professional engineering services agreement with Burns & McDonnell on October 7, 2019, to provide the design services for this project, and a public hearing was held on May 21, 2018.

Missouri Highway Transportation Commission (MHTC) will fund \$1,076,697.90 (90%) and the City will fund \$119,633.10 (10%) for a total construction cost of \$1,196,331.00.

An appropriation in the amount of \$1,076,697.90 being requested in this ordinance from the State contributions account.

Fiscal Impact
