Re: Authorizing the Mid Missouri Solid Waste Management District Waste Collection Event

Cooperative Cost Share Agreement

Executive Summary

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute the Mid Missouri Solid Waste Management District Waste Collection Event Cooperative Cost Share Agreement for a not to exceed amount of \$10,000.00. Mid Missouri Solid Waste Management District will coordinate and provide event support for a one-day solid waste collection event for Household Hazardous Waste, Electronic Waste and Tires.

Discussion

The City of Columbia, the County of Boone, and the Curators of the University of Missouri are co-permittees for the Missouri Department of Natural Resources State Operating Permit for the Phase II Municipal Separate Storm Sewer System (MS4). In the Joint Stormwater Management Program attached to the permit, the co-permittees have a measurable goal of holding a coordinated Household Hazardous Waste collection event annually, as funding permits, and that the event will include the collection of used tires. Since 2015, the City of Columbia, the County of Boone, and the Curators of the University of Missouri have partnered with the Mid Missouri Solid Waste Management District to fund a one-day solid waste collection event for household hazardous waste, electronic waste and tires. Each year, the event has collected between 70 and 125 tons of material that is properly disposed and therefore not disposed in a manner that would allow for damage our waterways.

The Mid Missouri Solid Waste Management District coordinates and provides event support for this one-day event. The event is held on the University of Missouri campus in late May or early June. In the past, each of the co-permittees have contributed annually to this event. This agreement is for an amount not to exceed \$10,000 and will be paid from Storm Water Utility Funds.
