Executive Summary

Setting a public hearing for June 1, 2020 for the construction of the Discovery Parkway Extension (Discovery Drive to Rolling Hills Road) project. The estimated total cost of the project is \$6,821,675.00.

Discussion

The Discovery Parkway Extension (Discovery Drive to Rolling Hills Road) project includes constructing approximately 7,715 linear feet of new roadway to connect the east end of Discovery Parkway at the Discovery Drive intersection to Rolling Hills Road just south of the intersection with New Haven Road. The roadway will include two driving lanes, bike lanes, and an eight-foot wide sidewalk/pedway. The site will be graded such that in the future the roadway can be expanded to four lanes with a median, bike lanes, and sidewalk along the southeast side of the roadway. The project has been coordinated with the University of Missouri Discovery Ridge project and the South Farm and will include the construction of two bridges to allow local traffic and farm service vehicles needed for the farm operations and an underpass crossing for livestock.

The design of this project has been completed by Allstate Consultants and the plans and specifications are signed and sealed. An IP meeting for this project was held on March 31, 2009 with approximately 16 people attending. The initial public hearing was held on March 1, 2010. Permanent street easements, drainage easements, and temporary construction easements have been acquired from the University of Missouri for this project.

The total project cost estimate for the Discovery Parkway Extension project is \$6,821,675.00 which includes design, easement acquisition, utility relocation and construction. The City has been awarded the Governor's Transportation cost-share program funds which will match up to 50 percent of the construction cost of this project; the estimated construction cost for this project is \$6,126,970.00. The City has also been awarded \$735,000 through a Federal Aid earmark for this project. The Governor's Transportation cost share agreement and the Federal Aid Program agreement will be included on a future Council agenda. The project is scheduled for construction to begin in the spring of 2021.

Fiscal Impact

Short-Term Impact: The estimated total project cost for the Discovery Parkway Extension project is \$6,821,675.00. The funding source is MoDOT cost share funds, federal aid funds, 1/4% CIP sales tax, county road tax, developer fees. Long-Term Impact: Routine maintenance.
