Re: Appropriate funds for the funding of bid alternatives for Hangar 730 construction.

Executive Summary

Appropriate funds received from The Kroenke Group (TKG) for the construction of their bid alternatives for Hangar 730.

Discussion

The RFP for construction of Hangar 730 included bid alternatives at the request of TKG. These bid alternatives were improvements above and beyond the replacement of Hangar 350. The Kroenke Group reviewed the bids that were received and accepted bid alternatives 1, 2, and 4. These improvements include a parking lot, gate, and office building attached to the hangar. The total cost of these improvements is \$332,400.00. The payment from TKG was received by the City of Columbia on May 4, 2020.

Staff is requesting the payment of \$332,400.00 be appropriated to AP130 to pay for the bid alternatives accepted by the City of Columbia and approved by TKG.
