#### **AN ORDINANCE**

vacating portions of street rights-of-way and utility easements located on the west side of Arbor Pointe Parkway between Atwood Court and Meandering Court; directing the City Clerk to have a copy of this ordinance recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council finds and determines that certain street rights-of-way and utility easements located on the west side of Arbor Pointe Parkway between Atwood Court and Meandering Court, more particularly described as follows, are in excess and surplus to the needs of the City and are hereby vacated:

## TRACT A Right-of-Way Vacation

A tract of land located in the East half of Section 20, Township 49 North, Range 12 West, City of Columbia, Boone County, Missouri, said tract being a portion of the right-of-way previously dedicated for Meandering Way as shown by the plat of The Villages at Arbor Pointe Plat 3, as recorded in Plat Book 41, Page 72 of the Boone County records. SECTION 3. This ordinance shall be in full force and effect from and after its passage.
