Re: Repealing Ordinance No. 024235 which authorized a first supplemental agreement to an airport aid agreement with the Missouri Highways and Transportation Commission relating to air service promotion for the Columbia Regional Airport; and authorizing a revised first supplemental agreement with MHTC

#### Executive Summary

Staff is requesting that Council authorize the repeal of Ordinance No. 024235 which authorized a first supplemental agreement to an airport aid agreement with the Missouri Highways and Transportation Commission (MHTC) relating to air service promotion for the Columbia Regional Airport; and authorize a revised first supplemental agreement with MHTC to include additional language.

#### Discussion

On May 4, 2020, Council Bill 101-20 was passed authorizing the City Manager to execute a first supplemental agreement to an airport aid agreement with MHTC. Staff is requesting that this Council Bill be rescinded due to two additional WHEREAS statements being added to the new updated agreement.

These additional statements are the following: WHEREAS, One Hundred Fifty Thousand Dollars (\$150,000) of the granted amount is intended to market new air service in support of the Sponsor's Small Community Air Service Development Grant; and WHEREAS, the new air service will not commence until 2021.

The Airport was originally awarded \$250,000 and has received reimbursement for \$100,000 of the original agreement approved on August 19, 2019, leaving this balance of \$150,000. This first supplemental agreement extends the period of time until August 1, 2021, which will allow staff to use the remaining funds for the promotion of new air service.
