Executive Summary

Authorize a bid call through the Purchasing Division for the construction of the Discovery Parkway Extension (Discovery Drive to Rolling Hill Road) project. An Interested Parties (IP) meeting for this project was held on March 31, 2009, the initial public hearing was held on March 1, 2010, and a second public hearing was held June 1, 2020.

Discussion

The Discovery Parkway Extension (Discovery Drive to Rolling Hills Road) project includes constructing approximately 7,715 linear feet of new roadway to connect the east end of Discovery Parkway at the Discovery Drive intersection to Rolling Hills Road just south of the intersection with New Haven Road. The roadway will include two driving lanes, bike lanes, and an eight-foot wide sidewalk/pedway. The site will be graded such that in the future the roadway can be expanded to four lanes with a median, bike lanes, and sidewalk along the southeast side of the roadway. The project has been coordinated with the University of Missouri's Discovery Ridge and the South Farm and will include the construction of two bridges to allow for farm service vehicles crossing needed for the farm operations and an underpass to allowing for livestock crossing.

The design of this project has been completed by Allstate Consultants and the plans and specifications are signed and sealed. An Interested Parties (IP) meeting for this project was held on March 31, 2009 with approximately 16 people attending the meeting. An initial public hearing for the project was held on March 1, 2010 and a second public hearing was held on June 1, 2020. Permanent street easements, drainage easements, and temporary construction easements for this project have been acquired from the University of Missouri. A location diagram and the final project plans are attached.

The total project cost estimate for the Discovery Parkway Extension project is \$6,821,675.00, this total includes design, utility relocation, the value of the donated easements and construction. Construction of the project will be funded with the Governor's Transportation cost-share program funds which would match up to 50 percent of the <u>construction</u> cost of this project. The estimated construction cost for this project is \$6,126,970.00. The City has also been awarded \$735,000.00 through a Federal Aid grant for this project. The City's match will be funded with the ¹/₄-percent CIP sales tax, County road tax, and developer fees. The project is scheduled for construction in spring of 2021.
