Re: Public Hearing - Proposed Construction of the St. Charles Road Sidewalk (Demaret Drive

to Battle Avenue) Project

### **Executive Summary**

A public hearing is being held for the proposed construction of the St. Charles Road Sidewalk (Demaret Drive to Battle Avenue) project. An online Interested Parties (IP) meeting was held from May 26, 2020 through June 8, 2020.

#### Discussion

The St. Charles Road Sidewalk (Demaret Drive to Battle Avenue) project will include the construction of a sidewalk along the north side of St. Charles Road between Demaret Drive and the property at the northwest corner of the intersection of St. Charles Road and Battle Avenue. The project length is approximately 3,100 linear feet with the majority of the sidewalk being constructed along the Lake of the Woods Golf Course property.

The preliminary sidewalk design includes a 5-foot wide concrete sidewalk with grass parkway between Demaret Drive and the entrance to the golf course and a 6-foot wide concrete sidewalk with concrete curb and gutter from the golf course driveway to the end of the project near Battle Avenue. The project also includes a crosswalk with a pedestrian flashing beacon at the intersection of St. Charles Road and Demaret Drive.

The sidewalk will be constructed along the Lake of the Woods Golf Course which is owned by the City's Parks and Recreation Department; therefore, permanent sidewalk easements (PSE) should not be necessary for construction of the project. Temporary construction easements and a permanent drainage easement may need to be acquired. An IP meeting was held online from May 26, 2020 through June 8, 2020, two comments were received from the IP meeting and are attached.

Construction of this project is currently scheduled to be completed during the Fall/Winter of 2020. The estimated total project cost for this sidewalk is \$688,600, this includes design, utility relocation, easements and construction. Columbia Public Schools is contributing 50 percent towards the total cost of the project per the Cost Allocation Agreement approved at the April 6, 2020 Council meeting.

### Fiscal Impact

Short-Term Impact: The estimated total project cost for the sidewalk is \$688,600 and will be funded by a 50/50 cost share with Columbia Public Schools. The City's 50-percent of the

cost share will be funded with the quarter-cent Capital Improvement Program sales tax and the City/County/State joint tax.
