Re: Streetlight Request – Edenton Boulevard

### **Executive Summary**

Staff has prepared for Council consideration a resolution approving the installation of street lights recommended by the Street Lighting Committee. The Street Lighting Committee, which is comprised of staff from the City's Water and Light, Public Works, Office of Neighborhood Services, Police, and Office of Sustainability, has received one request for additional streetlights.

1) Additional lighting along Edenton Boulevard between International Drive and the northern terminus.

The Street Lighting Committee has reviewed this request and recommends the following:

1) Installing 3 additional streetlights along Edenton Boulevard from the intersection of International Drive to the northern terminus as shown in Exhibit A.

#### Discussion

A request for additional lighting along Edenton Boulevard north of International Drive has been submitted to the Street Light Committee. After review, it has been determined that Edenton Boulevard is currently lit consistent with Chapter 27-150 of the City's code of Ordinances in regards to street lighting on local non-residential streets along the southern section to International Drive, but not to the northern terminus. To satisfy the requests for additional lighting, the streetlight committee recommends Installing 3 additional streetlights along the northern terminus of Edenton Drive as shown in Exhibit A. The requested streetlights are located within Boone Electric Cooperative's service territory. The streetlights are proposed to be 250 watt high pressure sodium luminaires mounted on new steel poles. Reoccurring costs would be \$26.25 per month per light or \$945 annually.
