Re: Granting a Water Line Easement to Consolidated Public Water Supply District No. 1 to Relocate a Water Line along Route K Necessary for the Construction of a Roundabout at the

Intersection of Sinclair Road, Route K and Old Plank Road.

### **Executive Summary**

Authorizing the City Manager to execute a Water Line Easement with Consolidated Public Water Supply District No. 1 (CPWSD#1) for the relocation of a water line necessary for the construction of a roundabout at the intersection of Sinclair Road, Route K and Old Plank Road.

#### Discussion

This intersection improvement project will improve long-term safety at the Sinclair Road, Route K and Old Plank Road intersection with the construction of a roundabout. Currently, the north leg (Sinclair Road) and the south leg (Old Plank Road) of the intersection are offset from each other. The improvement will align the two legs and provide other safety features associated with a roundabout, such as slowing the vehicles through the intersection. The roundabout is sized to accommodate large size vehicles and school busses, and will be lighted. Sidewalks will be constructed along the roundabout and will tie into existing sidewalks adjacent to the project. An Interested Parties meeting was held on May 9, 2019 and the public hearing was held on July 1, 2019.

Extensive street right-of-way already exists at the intersection. When the Cascades Subdivision was developed northeast of the intersection in the early 2000s, right-of-way and a utility easement were platted at the northeast corner in anticipation of a future intersection improvement project which would relocate Sinclair Road to the east in order align with Old Plank Road. The sidewalk at the Cascades Park was also constructed to accommodate the realignment of Sinclair Road.

With the construction of the Sinclair Road, Route K and Old Plank Road intersection improvement project, CPWSD#1 will need to abandon their existing easement and relocate their water line, requiring an additional 10-foot wide water line easement that runs adjacent to the utility easement. The easements runs along the north side of Route K on the Cascades Park property. This easement will allow for the required 10-foot separation between water lines and sewer lines when CPWSD#1 relocates the water line.

Staff is requesting Council authorize the City Manager to execute a Water Line Easement for water utility purposes to CPWSD #1 for the relocation of a water line along Route K to accommodate the construction of a roundabout at the intersection of Sinclair Road, Route K and Old Plank Road.
