Taxiway C2 and Apron Expansion Project at the Columbia Regional Airport.

Executive Summary

Authorizing an Airport Aid Agreement with the Missouri Highways and Transportation Commission (MHTC) and amending the FY 2020 Annual Budget by appropriating \$221,809.10 in grant funds relating to the reconstruction of Taxiway C2 and Apron Expansion project at the Columbia Regional Airport.

Discussion

This agreement allows for the reconstruction of Taxiway C2 and apron expansion at Columbia Regional Airport. It coincides with the new design-build of Hangar 730, which will replace Hangar 350.

Initially, the estimated cost for construction of this project was \$1,196,331. However, the total project cost came in higher at \$1,442,786 which is a difference of \$246,455. The increase in cost increases the state's 90% contribution amount by \$221,809.10. With this legislation, staff is requesting to appropriate these additional funds for a total state contribution amount of \$1,298,507. The City's 10% match is \$144,279 for a total project cost of \$1,442,786. A previous MoDOT appropriation in the amount of \$1,076,697.90 was appropriated on April 6, 2020, and the City's 10% match of \$144,279 was appropriated in the FY 2020 budget.

Staff is requesting that Council authorize the City Manager to execute the Airport Aid Agreement with MHTC and appropriate \$221,809.10 from the state revenue account to the capital improvement project account AP140.
