- The park should stay as it is so as to not disturb the wildlife that live and migrate thru there. The apartments have already taken a large toll on this as have their pets that they do not pick up after. It was a very enjoyable walk, somewhat less with the apartments, but with the large parking lots, buildings, and the clientele that will bring it will not be worth the drive out there as there will be nothing left to enjoy but buildings and too many people. This will not be an improvement but a bigger desecration.

- I'd like to see a paved path to the water. I'm sure there will be many events that spill outside to the water's edge and people who use wheelchairs will feel isolated if they can't get out there.
- Why is the City using Parks Tax money to create a meeting space that will compete with private businesses? Couldn't that money be better spent on actual parks / fields improvements? How about lighting for the athletic fields across the street? Further, what is the justification for moving the existing trail off the lake, through the parking lot, so that the event center will have "private lake access?" Really? The trail likely gets used all day every day in the warmer months, the event center likely a few hours per week. Would the City move a public trail if a private business wanted to create "private lake access?" I doubt it very much.
