Re: Authorizing construction of the PCCE #21 Stanford Drive Sanitary Sewer Improvement

Project and calling for bids through the Purchasing Division.

#### **Executive Summary**

Staff has prepared for Council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the PCCE #21 Stanford Drive Sanitary Sewer Improvement project, as shown on the attached Location Map. A public hearing was held on February 17, 2020. The resolution estimate for this project is \$150,000 and will be paid from the Sewer Utility Private Common Collector Elimination funds.

#### Discussion

The Stanford Drive PCCE #21 Sanitary Sewer Improvement Project will consist of constructing 125 feet of new sewer pipe and one (1) sanitary sewer structure, as shown on the attached Diagram. Staff anticipates utilizing the term and supply contract for this project. However, this ordinance authorizes construction either through the City's term and supply contract or by bidding through Purchasing, whichever is most appropriate.

Sewer Utility Staff held an Interested Parties meeting on December 4, 2019. A public hearing for Stanford Drive PCCE #21 Sanitary Sewer Improvement Project was held on February 17, 2020. The resolution estimate for this project is \$150,000 to be paid from Sewer Utility Private Common Collector Flimination funds.

Construction plans are 100 percent complete, and all necessary easements have been obtained. Construction is expected to begin in FY2021.

### Fiscal Impact

Short-Term Impact: The resolution estimate is \$150,000 for this project and will be paid from the Sewer Utility Private Common Collector Elimination funds.

Long-Term Impact: It is anticipated that this project will have a minimal impact on the Sewer Utility's annual operating cost.
