#### Executive Summary

Staff has prepared for Council consideration an ordinance authorizing construction and a call for bids through the Purchasing Division for the Quail Drive Stormwater Improvement project. See the attached Location Map. A public hearing was held on November 18, 2019. The resolution estimate for this project is \$525,000 and will be paid from Storm Water Utility funds. This work was on the list of projects associated with the stormwater ballot initiative in 2015.

#### Discussion

The Quail Drive Stormwater Improvement Project will consist of constructing approximately 670 feet of new stormwater pipe, six stormwater inlets, and two stormwater structures, as shown on the attached Diagram. The project also includes construction of approximately 210 feet of gravity sanitary sewer main and two sanitary sewer structures that need to be relocated to accommodate the new stormwater pipe within the existing utility and drainage easement.

Storm Water Utility Staff held an Interested Parties meeting on August 7, 2019. A public hearing for the Quail Drive Stormwater Improvement Project was held on November 18, 2019. The resolution estimate for this project is \$525,000 and will be paid from Storm Water Utility funds.

Construction plans are 95 percent complete, and construction is expected to begin in FY2021.

#### Fiscal Impact

Short-Term Impact: The resolution estimate for this project is \$525,000 and will be paid from the Stormwater Utility funds.

Long-Term Impact: It is anticipated that this project will have minimal impact on both the stormwater and sanitary sewer utilities' annual operating cost.
