# **Columbia Parks and Recreation Commission**

**Re:** P&R Commission FY2021 Budget Recommendation

The Parks and Recreation Commission considered the proposed FY2021 budget for the Parks and Recreation Department at our August 20 meeting. Director Mike Griggs shared a detailed presentation and the Commission discussed the proposed budget.

The Commission asked that I send you key points from the discussion:

- Park and recreation professionals are on the frontlines of the COVID-19 pandemic providing face to face interaction with numerous members of the public. Additionally, P&R staff perform similar duties as those in solid waste, streets, utilities and public safety (trash pickup, equip operation, electrical/sewer, drowning prevention and CPR, etc). The Commission recommends that Parks and Recreation staff who perform the same or similar tasks as other City employees be given the same financial consideration related to benefits and compensation as those that are represented by labor unions.
- During the COVID-19 pandemic, citizens voted with their feet and were visiting parks and trails in never before seen numbers. Research has shown that parks, trails and greenspaces provide crucial health and wellness benefits. The Commission is concerned about the level of budget cuts implemented to the General Fund portion of the Parks and Recreation budget when the sales tax revenues to date have proved to be flat instead of in rapid decline as originally predicted as a consequence of COVID-19.
- Recreation programs that encourage physical activity and those that provide social interaction and mental challenges are critical in reducing stress and anxiety. The Commission is concerned about the 14.7% increase in intergovernmental charges to the Rec Services Fund and recommends a review of how intergovernmental charges are allocated so that annual increases are fair and equitable across the various City funds and departments. Uncontrolled costs like this will have to be passed on to the public, or services eliminated.
- Because of the increased responsibilities related to the addition of the GCRA X-Country Course, Fairgrounds, and MKT Trail to Hindman Junction, the Commission recommends that priority be given to restoring the P&R positions that were eliminated due to budget cuts once City funding stabilizes.

At the end of the discussion, the Commission made the following motion: Commissioner Chad Henry made a motion, seconded by Commissioner Sue Davis, that the Commission recommends approval of the Parks and Recreation FY2021 budget as presented. Motion passed 5-0.
