Re: Authorizing a Waterline Replacement Contract with Consolidated Public Water Supply District No. 1 of Boone County, Missouri Relating to the Construction of the Sinclair Road,

Route K, and Old Plank Road Intersection Improvement Project.

Executive Summary

Authorize the City Manager to execute a Waterline Replacement Contract with Consolidated Public Water Supply District No. 1 for the Sinclair Road, Route K, and Old Plank Road Intersection Improvement project. The improvement includes relocating the waterline along the north side of Route K during construction of a roundabout.

Discussion

This roundabout project will improve long term safety at the Route K/Sinclair Road/Old Plank Road intersection with the construction of a roundabout. Currently, the north leg (Sinclair Road) and the south leg (Old Plank Road) of the intersection are offset from each other. The improvement will align the two legs plus provide other safety features associated with a roundabout, such as slowing the vehicles through the intersection. The roundabout is sized to accommodate large size vehicles and school busses, and will be lighted. Sidewalks will be constructed along the roundabout and will tie into existing sidewalks adjacent to the project. An Interested Parties (IP) meeting was held on May 9, 2019, and the Public Hearing was held on July 1, 2019.

Final plans and specifications are being completed by Burns and McDonnell, the engineering consultant for this project. As part of the development of final plans for the project, it was determined that the Consolidated Public Water Supply District No. 1 waterline needs to be relocated to allow for the construction of the roundabout. Bartlett and West is currently designing this waterline relocation. The City will include relocating the District's waterline as part of the construction project for the roundabout as outlined in this Waterline Replacement Contract. The project is planned to be bid in January or February of 2021 with construction starting in the spring of 2021. Temporary closures and detours will likely be required during construction.

The total estimated project cost (design, utility relocation, construction) is \$1,246,375. The Missouri Department of Transportation (MoDOT) will fund 50% (not to exceed amount of \$623,187) of the cost through the Cost Share Partnership Funding program, Columbia Public Schools (CPS) will pay a lump sum payment of \$169,723, and the City will be responsible for \$453,465, to be paid from the quarter-cent Capital Improvement Program sales tax.
