Re: Authorize Aviation Project Consultant Supplemental Agreement No. 1 with Burns & McDonnell Engineering Company, Inc. for Construction Phase Services related to the extension of Runway 2-20 at the Columbia Regional Airport

Executive Summary

Staff is requesting Council authorize the City Manager to execute Aviation Project Consultant Supplemental Agreement No. 1 with Burns & McDonnell Engineering Company, Inc. for construction phase services related to the extension of Runway 2-20 at the Columbia Regional Airport, in the amount of \$959,886.

Discussion

On January 7, 2019, Council Bill 317-18 was passed authorizing an Aviation Project Consultant Agreement with Burns & McDonnell Engineering Company, Inc. to provide design services related to the extension of Runway 2-20 which reflected an additional 900 feet to the north end of the primary runway. Thus allowing for larger aircraft and enhancing the safety of aircraft currently utilizing the runway.

Staff is requesting Council authorize the City Manager to execute Supplemental Agreement No. 1 with Burns & McDonnell Engineering Company, Inc. for additional services not included in the original agreement for design services. The additional services include Resident Engineer on site during duration of construction, materials testing, and contract administration of the Runway 2-20 extension project, for a not to exceed amount of \$959,886. The FAA has approved this additional amount for 100% reimbursement. Construction of the Runway 2-20 extension project is planned to begin in the spring of 2021.

Fiscal Impact

Short-Term Impact: Supplemental Agreement No. 1 is for a not to exceed amount of \$959,886 and will be reimbursed at 100% by the FAA.

Long-Term Impact: Total project cost for construction is estimated at \$9,985,795 and will be reimbursed by the FAA at 100%.
