AVIATION PROJECT CONSULTANT SUPPLEMENTAL AGREEMENT NO. 2 ADDITIONAL DESIGN SERVICES

THIS SUPPLEMENTAL AGREEMENT NO. 2 for Additional Design Services is entered into by the City of Columbia, Missouri (hereinafter, "Sponsor") and BURNS & MCDONNELL ENGINEERING COMPANY, INC. (hereinafter, "Consultant").

WITNESSETH:

WHEREAS, the Sponsor and the Consultant entered into an Agreement on 1/9/2019, to accomplish a project at the Columbia Regional Airport related to the design of the Extension of Runway 2-20 for nine hundred feet to the North, (hereinafter, "Original Agreement"); and

WHEREAS, the Sponsor and the Consultant now desire to enter into Supplemental Agreement No. 2 to otherwise complete, extend or continue the Original Agreement as provided herein.

NOW, THEREFORE, in consideration of the mutual promises, covenants, and representations contained herein the parties agree as follows:

SCOPE OF SERVICES: (1)

(A) The Services to be provided by the Consultant under Supplemental Agreement No. 2 are additional services which are beyond the scope of services provided in the Original Agreement and Supplemental Agreement No. 1. These additional professional services are generally described and defined in Section (16)(State) or (17)(Federal) of the Original Agreement and Exhibit II - SA2, which is attached hereto and incorporated herein by reference.

FEES AND PAYMENTS: (2)

- The Consultant shall be reimbursed in accordance with Section (A) (8)(State) or (9)(Federal) of the Original Agreement.
- The costs of Supplemental Agreement No. 2 shall be in addition to the cost of the Original Agreement and the costs of Supplemental Agreement No. 1.
- The lump sum fee and maximum amount payable included in Section (8)(State) or (9)(Federal) of the Original Agreement are hereby modified as follows:

- (D) Estimated costs for the services in Supplemental Agreement No. 2 are defined in Exhibit IV SA2 and Exhibit V SA2, which are attached hereto and incorporated herein by reference.
- (3) PERIOD OF SERVICE: Exhibit VI, Performance Schedule, of the Original Agreement is hereby revised to include time for the performance of these additional services. The total time to be added to Exhibit VI for completion of these additional services shall be ninety (90) calendar days. The projected design completion date shown on Exhibit VI is now revised to 360 calendar days for tasks B.1, B.2 in the original agreement and Supplemental Agreement No. 2, which includes time for performance of all remaining services in the Original Agreement and the services in Supplemental Agreement No. 2 and submittal of all design deliverables.

(4) <u>DISADVANTAGED BUSINESS ENTERPRISE (DBE) REQUIREMENTS:</u>

- (A) <u>DBE Goal</u>: The following DBE goal has been established for this Supplemental Agreement No. 2. The dollar value of services and related equipment, supplies, and materials used in furtherance thereof which is credited toward this goal will be based on the amount actually paid to DBE firms. The goal for the percentage of services to be awarded to DBE firms is 0.0% of the total Supplemental Agreement No. 2 dollar value.
- (B) <u>DBE Participation Obtained by Consultant</u>: The Consultant has obtained DBE participation, and agrees to use DBE firms to complete 0.0% of the total services to be performed under this Supplemental Agreement No. 2 by dollar value. A. PROJECT NAME:

 Project Name: Design Amendment for Extend Runway 2-20 900' to the North at the Columbia Regional Airport (COU) in Columbia, Missouri. This work, as requested by the Federal Aviation Administration (FAA), will be a supplemental agreement to the Design Phase Services for the Extend Runway 2-20 900' to the North and funded under AIP 3-29-0022-049.

2. Description of Improvements:

The description of planned improvements not included in the original Scope of Work are described herein as follows:

- a. Runway Safety Area (RSA) Grading within the footprint of the existing Runway 2-20 RSA south of the Taxiway B intersection. The existing RSA grades are less than the minimum specified under current FAA Criteria per FAA Advisory Circular 5300-13A. As a result, the existing Runway 2-20 RSA south of Taxiway B will be regraded to meet current FAA RSA standards. See Exhibit 1 below.
- b. Additional Runway 2-20 NAVAIDS Preparation including Electronics Package.
- c. PAPI Clearance Surfaces Survey (Subconsultant Assistance) as per Engineering Brief No. 95 -Additional Siting and Survey Considerations for Precision Approach Path Indicator (PAPI) and Other Visual Glide Slope Indicators (VGSI).



B. DESCRIPTION OF SERVICES TO BE PERFORMED

b.PAPI Clearance Surfaces Survey (Subconsultant Assistance). The Consultant will provide, through the services of a Registered Land Surveyor in the State of Missouri, a PAPI Light Signal Clearance Surface (LSCS) Survey per Engineering Brief No. 95 as directed by FAA Technical Operations. This effort includes the survey field work and submittal of the survey results information to the FAA for evaluation.

c. ESTIMATED TIME OF COMPLETION:

1. The time to complete the Scope of Services for Items identified in B.1. of this Scope of Work is estimated at ninety (90) calendar days from the Notice to Proceed (NTP).
