Executive Summary

Authorize the City Manager to execute a first amendment to the intergovernmental cooperation agreement with the Curators of the University of Missouri for integrated shuttle bus service on campus for the remainder of the academic year.

Discussion

Go COMO staff was contacted by the University of Missouri Parking and Transportation interim director regarding amending the current approved agreement for shuttle services, specifically, to reduce the number of buses on two (2) daytime routes from three (3) per route to two (2) buses per route.

Due to decreased in-seat classes being held on campus, ridership on the routes has been affected to the point that the three (3) buses originally assigned to these routes can be reduced to two (2) buses. The University's budgetary savings by reducing the number of buses in daytime service is needed at this time.

Fiscal Impact

Short-Term Impact: The reduction in revenue equals \$209,040 bringing the contracted amount for the 2020-21 year to \$1,053,600.

Long-Term Impact: Unknown at this time.
