Re: Authorizing the Installation of Audible Pedestrian Signals with Countdown Timers, and the Reconstruction of Sidewalk Ramps at the Intersection of Route 763 (Rangeline Street) and

Smiley Lane; Calling for Bids through the Purchasing Division.

## **Executive Summary**

Staff is requesting council authorize a bid call through the Purchasing Division for the construction of the Route 763 (Rangeline Street) and Smiley Lane Intersection Audible Pedestrian Signal (APS) project. This project will include the installation of new signal equipment including audible pedestrian signals with countdown timers, the reconstruction of two sidewalk ramps on the northeast and southwest corners of the intersection, and repainting the existing pedestrian crossing markings. An online Interested Parties (IP) meeting was held from September 14, 2020 through September 25, 2020 and the public hearing was held on November 2, 2020.

#### Discussion

Currently, the Route 763 and Smiley Lane intersection has conventional pedestrian signs and signals and two sidewalk ramps on the northeast and southwest corners of the intersection do not meet current Americans with Disabilities Act (ADA) criteria. The design includes the installation of new signal equipment including audible pedestrian signals with countdown timers at the intersection, reconstruction of the sidewalk ramps on the northeast and southwest corners, and the existing pedestrian crossing markings will be repainted.

The installation of an audible pedestrian signal at this location was requested by the Columbia Chapter of the National Federation of the Blind of Missouri. The project was also discussed at the Disabilities Commission meeting on March 12, 2020. No easements are expected to be needed for the proposed improvements.

An online Interested Parties meeting was held from September 14, 2020 through September 25, 2020. Two positive responses were received. A public hearing was held on November 2, 2020.

Construction of the project is currently scheduled to begin in spring of 2021. The total estimate cost for this project is \$83,000 (Construction, design and inspection). The project will be funded with the ½ Cent Capital Improvement Program sales tax.
