Council Meeting Date: December 21, 2020 Re: Proposed Amendments to Chapter 21

### **Executive Summary**

The Citizens Police Review Board respectfully requests that the City Council amend Chapter 21 to increase the number of days to file an appeal or to request limited review from twenty-one (21) to thirty (30) days. In addition, the Citizens Police Review Board requests that Council grant the Board the ability to vary from or waive any of the requirements of Chapter 21, Article III upon a finding of good cause.

#### Discussion

On July 8, 2020, and again on August 12, 2020, the Citizens Police Review Board discussed providing more access to civilian oversight by increasing the deadlines for requesting review or appeal to thirty days. The deadlines are currently set at twenty-one days. The board unanimously passed motions to send these recommendations to Council.

In Article III of Chapter 21, there are three sections that provide time limits for filing appeals.

Section 21-51 provides that appeals to the board must be filed "within twenty-one (21) days after the notice of the chief's decision was given."

Section 21-51.1 states that "[r]equests for limited review pursuant to this section shall be filed with the city clerk within twenty-one (21) days after the person is given notice of the determination by the police chief."

Section 21-53 sets forth the requirements for complainants, officers, and community service aides to file appeals to the City Manager or to the Personnel Advisory Board. The time limits in this section are currently set at twenty-one days after notice of the right to appeal has been given.

The Board also passed a motion to recommend that the City Council amend Article III of Chapter 21 to grant the Board the authority to vary from or waive any requirement in the Article upon a finding of good cause. The Board feels that these changes will increase access to civilian oversight and, as a result, increase the public's trust.
