Re: Authorizing construction of the Tupelo Larch Sanitary Sewer Improvement project and

calling for bids through the Purchasing Division.

Executive Summary

Staff has prepared for the council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the Tupelo Larch Sanitary Sewer Improvement project, as shown on the attached Location Map. A public hearing was held on November 18, 2019. The resolution estimate for this project is \$235,000 and will be paid from Sewer Utility funds.

Discussion

The Tupelo Larch Sanitary Sewer Improvement project will consist of constructing 474 feet of new sewer pipe and two sanitary sewer structures, as shown on the Project Graphic. The existing sanitary sewer pipe system and two existing structures will be abandoned and/or removed. Staff anticipates utilizing the term and supply contract for this project. However, this ordinance authorizes construction either through the City's term and supply contract or by bidding through the Purchasing Division, whichever is most appropriate.

Sewer Utility Staff held an Interested Parties (IP) meeting on July 31, 2019. A public hearing for the Tupelo Larch Sanitary Sewer Improvement project was held on November 18, 2019. The resolution estimate for this project is \$235,000 and will be paid from Sewer Utility funds.

Construction plans are 95% complete, and all necessary easements have been obtained. Construction is expected to begin in 2021.

Fiscal Impact

Short-Term Impact: The resolution estimate is \$235,000 for this project and will be paid from the Sewer Utility funds.

Long-Term Impact: It is anticipated that this project will have a minimal impact on the Sewer Utility's annual operating cost.
