### **Executive Summary**

Staff has prepared for Council consideration an ordinance authorizing the City Manager to execute a fourth amendment to a solar power purchase agreement and a first amendment to an interconnection agreement with Truman Solar, LLC.

#### Discussion

Truman Solar, LLC has recently contacted staff and has requested the power purchase agreement be amended to extend the commercial operation date for the solar project from January 31, 2021 to April 1, 2021 due to project financing issues. In exchange for the delay in delivery of solar energy, Truman Solar, LLC has agreed to pay an inconvenience fee of \$9000. This amount will allow the electric utility to purchase Renewable Energy Credits (RECs), to replace the renewable energy credits that would have been generated by the project for the term of the delay in the commercial operation date. The amendment also changes the address of Truman Solar, LLC due to it being purchased by CarVal Investors, LLC.

The interconnection agreement with Truman Solar is also requested to be amended. The amendments to the interconnection agreement includes details of how the facility will be operated and connected to the electric utility, and provides details on the facility specifications.

The electric utility has completed construction of the necessary feeders to take delivery of energy from the solar project. Construction of the Truman Solar facility is on-going and they have requested energization of the necessary lines in March in time for an April 1 commercial operation date.

#### Fiscal Impact

Short-Term Impact: Truman Solar will pay a \$9000.00 inconvenience fee which will be utilized to purchase renewable energy credits to replace the credits that would have been generated by the project due to the delay in the commercial operation date. Long-Term Impact: None
