Re: Public Hearing for Amendment #4 to the FY 2019 CDBG and HOME Annual Action Plan

Incorporating Round 3 CDBG –CV Funds Allocated Through the CARES Act

Executive Summary

HUD guidance has directed cities to incorporate Community Development Block Grant (CDBG) funds authorized through the Coronavirus Aid, Relief and Economic Security (CARES) Act as substantial amendments to their FY 2019 Annual Action Plans. HUD identifies these funds as CDBG-CV. Round 1 CDBG-CV funds included \$573,473 and was approved by Council in July of 2020. Round 3 includes \$737,588 in additional CDBG-CV funding through the CARES Act. Funding must be allocated to prevent, prepare and respond to needs directly related to the impacts of the COVID-19 Pandemic. This Council action is to hold a hearing to consider allocation plans for \$737,588 in CDBG-CV Round 3 funds and reallocation of \$60,000 in CDBG-CV Round 1 funds.

Discussion

The City of Columbia was awarded an additional \$737,588 in CDBG-CV funds through the Coronavirus Aid, Relief and Economic Recovery (CARES) Act. These funds were allocated by Congress on March 27, 2020 in direct response to the impact of COVID-19. CDBG-CV funding must be allocated to activities that directly address the impacts of COVID-19. The legislation calls for \$5 billion in CDBG-CV funding to be allocated in 3 rounds as follows:

Round 1: \$2 billion traditional formula allocation to entitlement jurisdictions

Round 2: \$1 billion to states based upon HUD determined formula for the impact of COVID-19

Round 3: \$2 billion to entitlement jurisdictions based upon the impact of COVID-19

Both City Council and HUD previously approved the City's Round 1 CDBG-CV funding allocation plan. City Council also previously approved amending FY 2019 and FY 2020 CDBG and HOME funding to assist with additional responses to the impact of COVID-19 and long term recovery efforts. A comprehensive list of previously approved CDBG-CV, FY 2019/2020 CDBG and HOME funding allocations for response to the impacts of COVID-19 are as follows:

Round 2 HUD allocations include \$17,913,300 in CDBG-CV funds to the state of Missouri. The federal legislation does allow these funds being administered by the state to be allocated to entitlement jurisdictions such as the City of Columbia; however, the State has not yet released any specific information on process or funding priorities. Staff will be attending an informational session on potential state plans for use of their CDBG-CV funds on February 4, 2021.

The CDBG-CV Round 3 funding award for the City of Columbia is \$737,588, as well as a reallocation \$60,000 in CDBG-CV Round 1 funds previously budgeted for Room at the Inn. Housing Programs Division (HPD) staff conducted additional public engagement to ensure community driven priorities assisted in shaping funding recommendations. The public engagement process included a public hearing at the October 21st Housing and Community Development (HCDC) meeting for the purpose of obtaining public feedback on housing and community development needs related to the impact of COVID-19. HPD staff also conducted a survey on funding priorities for Round 3 CDBG-CV throughout October and November. The survey included a rating of HUD eligible funding priorities and needs for use of CDBG-CV funding. Respondents were asked to rate a list of needs on a scale of 1 to 5 with five identifying very high priority rating. Survey results to date are as follows:



Staff also utilized local community volunteers to conduct a series of virtual public engagement sessions on October 28th and 29th. The virtual public engagement sessions included 27 participants. Much of the feedback aligned with the survey topics and associated ratings. Videos of the group meetings were also posted on the HPD webpage of the City website. Virtual public engagement sessions included the following questions:

1. How has the COVID-19 pandemic impacted your household's ability to manage your daily life responsibilities?

- 2. What housing and community development needs have been amplified the most by the impact of the COVID-19 pandemic? What type of support is most critical to helping low to moderate income households adapt and become more resilient to the pandemic?
- 3. What is your hope for our City's future as we continue to work through this crisis and become more resilient as a community?

The primary role of the Housing and Community Development Commission (HCDC) has historically been to provide recommendations for CDBG and HOME funding to the City Council. The HCDC conducted the following process timeline for developing funding recommendations for Round 3 CDBG-CV funding.

February 1, 2021: Council Considers CDBG-CV Round 3 Allocation Plan and Amendment to

FY 2019 Annual Action Plan

February 3, 2021: End of 30-day comment period

February 4, 2021: CDBG-CV Round 3 Plan Submission to HUD

February 12, 2021: Estimated date of HUD approval

March 1, 2021: Estimated project agreement for Council consideration for projects exempt or categorically excluded and not subject to NEPA and 24 CFR Part 58 Environmental Review Procedures

April 5, 2021: Estimated project agreement for Council consideration for projects subject to NEPA and 24 CFR Part 58 Environmental Review Procedures

May 3, 2021: Estimated project agreement for Council consideration for projects subject to NEPA and 24 CFR Part 58 Environmental Review Procedures and requiring full environmental assessment.

Annual CDBG and HOME allocations are guided by funding percentages identified within the Council Policy Resolution for CDBG and HOME. This policy framework has assisted in ensuring funds are allocated in a strategic manner that also align with community identified priorities. The HCDC utilized a similar approach in developing funding recommendations for Round 3 CDBG-CV funding. A significant portion of City funds, County funds and other federal funds have been provided to local small businesses, therefore staff and the HCDC removed small business assistance as a priority for Round 3 CDBG-CV funding. City staff and the HCDC formulated funding percentages for guiding allocation category

recommendations based upon survey feedback and public engagement sessions. The funding allocation categories identified were as follows:

The HCDC included these funding allocation priorities in the CDBG-CV Round 3 Request for Proposals (RFP) for qualified local non-profit organizations to submit funding requests. An RFP was issued under the following schedule:

November 20, 2020: Released the RFP

November 24, 2020: RFP Informational Meeting for Interested Application Organizations

December 11, 2020: RFP Due 11:59pm

December 16, 2020: HCDC Funding Allocations Meeting

There were fourteen proposals received. Two proposals were rejected due to being incomplete and not providing additional requested materials prior to the proposal submission deadline. Eligible proposals included over \$1.7 million in funding requests, while there was \$797,588 available

Given strict expenditure deadlines, cash management requirements and a multitude of federal regulations, HUD requires entitlement jurisdictions, such as the City of Columbia, to conduct risk assessments and evaluation criteria for sub-recipient organizations. Commissioners scored each proposal submitted, prior to public presentations, on 9 different rating criteria categories. The rating criteria is one that has been approved and modified by the collective commission year after year. Rating criteria subjects are as follows:

- Organization & Management
- Financial Management
- Past Performance
- Community Need
- Quality of Outcomes
- Number of Persons Served Per Dollar Expended
- Personnel and Staff Expertise
- Project Location
- Timeline

The HCDC listened to proposal presentations and voted on funding recommendations at its December 16, 2020 meeting. HCDC recommendations will be presented before Council as an amendment to the FY 2019 Annual Action Plan at the February 1, 2021 Council meeting. The HCDC's funding recommendations are included within the FY 2019 Annual Action Plan Amendment and as follows:

Notable outcomes and indicators of a comprehensive, transparent and community driven process is as follows:

- Significant level of public input from a diverse cross-section of members of the public.
- Public input from variety of means including public hearings, survey, public engagement meetings via Zoom, and Boone County Emergency Response Teams.
- Additional reports to City Council on progress and approaches to formulating plans and recommendations.
- Additional report on how other cities are using CDBG funds for COVID response informed survey of funding needs and strategic priorities.
- Awareness of other local funding source uses, therefore no small business assistance.
- More proposals received than typical annual process.
- Highest attended RFP information and education session on record.
- More new activities and organizations funded than in previous funding rounds.
- Significant levels of funding for previously funded organizations with significant capacity, as well as funding for new small startup organizations.
- Recommendations were thoroughly deliberated in open meeting and reflective of the collective HCDC as well as the individual members of the commission.

To date, the HPD has overseen approximately \$3 million in funding allocations related to COVID response and recovery efforts. Staff included these total budget allocations, as well as recommended Round 3 allocations to ensure City Council was provided the full scope of response and recovery efforts with the HPD, while considering Round 3 recommendations. A comprehensive spreadsheet of all budget allocations related to HPD COVID response and recovery efforts, as well as Round 3 recommendations, is as follows:
