Executive Summary

Staff is requesting council authorize the City Manager to execute a second amendment to the intergovernmental cooperation agreement with the Curators of the University of Missouri for integrated shuttle bus service on campus for the remainder of the academic year.

Discussion

COVID has had a debilitating effect on student's ability to attend in-seat classes at the University of Missouri. As a direct result, parking lots where commuting students are normally assigned and shuttle service is provided are not in use for the spring 2021 semester.

GoCOMO staff was contacted by the University of Missouri Parking and Transportation Director regarding amending the current approved agreement for shuttle services for a second time in the agreement term. The University is requesting to eliminate the RP10, Research Reactor Route (403 Route), effective November 1, 2020 thru the 2020-2021 academic year, and that fund allocated for the Research Reactor Route be refunded by GoCOMO for this time period.

The first amendment reduced the number of buses on two (2) daytime routes from three (3) buses per route, to two (2) buses per route, due to low ridership. The reduction in revenue equaled \$209,040 and brought the contracted amount for the 2020-2021 academic year to \$1,053,600. The second amendment will reduce revenue by \$201,120 bringing the contracted amount for the 2021-2021 academic year to \$852,480.

Fiscal Impact

Short-Term Impact: The reduction in revenue equals \$201,120 bringing the contracted amount for the 2020-21 year to \$852,480.

Long-Term Impact: Unknown at this time.
