Executive Summary

Staff has prepared for Council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing Division for the South Providence Road Sanitary Sewer Improvement project, as shown on the attached Location Map. A public hearing was held on July 6, 2020. The resolution estimate for this project is \$245,000 and will be paid from Sewer Utility funds.

Discussion

The South Providence Road Sanitary Sewer Improvement project will consist of constructing 366 linear feet of new gravity sewer pipe and two sanitary sewer structures, as shown on the attached diagram. The existing sanitary sewer pipe will be abandoned. This ordinance authorizes construction either through the City's term and supply contracts or by bidding through Purchasing, whichever is most appropriate.

Sewer Utility Staff held an Interested Parties (IP) meeting on January 9, 2020. A public hearing for the South Providence Sanitary Sewer Improvement project was held on July 6, 2020. The resolution estimate for this project is \$245,000 and will be paid from Sewer Utility funds. Construction plans are 95% complete, and all necessary easements have been obtained. Construction is expected to begin in Fall 2021.

Fiscal Impact

Short-Term Impact: The resolution estimate is \$245,000 for this project and will be paid from the Sewer Utility funds.

Long-Term Impact: This project will reduce the annual maintenance costs associated with cleaning this portion of the public sanitary sewer system.
