Executive Summary

Staff has prepared for Council consideration a resolution setting a public hearing on April 5, 2021 for the replacement of water distribution infrastructure near the intersection of Brown Station Road and Peabody Road. The estimated cost for this improvement is \$180,000. Funding is already appropriated under Capital Project W0230. An interested parties meeting for this project was held on March 14, 2019.

Discussion

The Columbia Water & Light Department has identified the need to replace water distribution infrastructure near the intersection of Brown Station Road and Peabody Road. The estimated cost of this project is \$180,000.

The existing water mains in this location are constructed of 16-inch cast Iron and have experienced localized corrosion due to site soil conditions. The observed corrosion is taking place on the exterior of the pipe and is limiting the longevity and structural integrity of the cast iron pipe. Investigations have been completed to determine the extent and limits of the observed corrosion. These investigations revealed the corrosion is focused primarily on a stretch of pipe near the Peabody Road intersection and adjacent to the Colt Railroad Trans-Load facility. The existing pipe will be replaced with new 16-inch ductile iron piping encased within a polyethylene lining to prevent future corrosion issues. This project will replace approximately 750 lineal feet of deteriorated pipe. The new water main will provide greater reliability for customer's water supply and reduce required maintenance. This water main replacement is planned to take place within existing right of way and on property owned by the City of Columbia for railroad operations.

As part of the public improvement process, staff sent letters to all customers and land owners in the affected areas and held an interested parties meeting on March 14, 2019. At this time, all feedback received from customers and residents has been in support of this water main replacement.

Funding has previously been appropriated under project number W0230 of the Capital Improvement Program.

Upon City Council approval of this resolution, a public hearing will be scheduled concerning construction of the water main replacement project on April 5, 2021.
